## How to join Achilles Supply-Line community

Visit [www.achilles.com/supply-line](http://www.achilles.com/supply-line) and click on **Join This Network** to start the application process to join the Achilles Supply-Line community.

The application process requires you to complete basic company details and select your subscription Level based on the Level Buyers typically use when purchasing services or products from your business. Once registration has been completed and payment for your annual subscription has been received, you will be sent details of how to access the online pre-qualification questionnaire.

This stage involves the submission of information and certificates related to finance, health, safety and environment, quality management, insurance, products and services and legal information.

## Choosing the right subscription level for your company

Achilles Supply-Line has 3 different subscription levels; your subscription Level is based on the value of the contract you typically carry out.

**Supply-Line Member Level** subscription allows you to compete for contract values **below EU threshold**. This subscription Level is free of charge to suppliers.

**Supply-Line Silver Level** subscription allows you to compete for contract values up to the European Thresholds.

**Supply-Line Silver+ Level** subscription allows you to compete for all contracts regardless of value.

- Access to search on OJEU
- Notification emails can be sent to up to 10 email contacts within your company

Achilles maps the company product/service registration with the CPV coding system used by Public/Utility buyers in European advertisements. This can be amended or expanded individually by companies to ensure all opportunities are captured and can be customised to search opportunities in certain countries only.
